Terms & Conditions

1. This is strictly a rental transaction, and does not constitute a hire purchase agreement.
2. During the rental period, the instrument remains the property of Pencerdd Ltd T/A Pencerdd Music.
3. The customer must show 2 forms of identification including current address. Identification containing address details must be from the previous 3 months.
4. The minimum rental period is 3 months, payable in advance, after which monthly payments will continue until the rental agreement is ended by the customer, which can be at any time by returning the instrument in good condition.
5. No rental-payments will be refunded should the instrument be returned before the end of the initial 3 month period, or after a monthly payment due date.
6. Please inform us by the 1st of the month (20 days notice) if you wish to cancel your agreement, otherwise your next monthly payment will be taken and is non-refundable. You must then return the instrument before the 20th.
7. You must agree to us taking monthly payments by Direct Debit through GoCardless, set up online, after the initial 3 months.
8. Direct Debits are taken on the 20th of the month. The first debit will include any extra days up to the 20th and future payments will thereafter be the normal monthly amount.
9. You must inform us of any changes to your details.
10. The customer will take all reasonable steps to protect the instrument from loss or damage.
11. If the instrument is returned in a damaged state, the customer must pay the cost of repair or the depreciation. Missing accessories must be replaced and paid for on return of the instrument.
12. The Customer will advise Pencerdd Ltd immediately in writing in the event of loss or damage, and will be held responsible for such loss or damage.
13. Pencerdd Ltd reserves the right to make a charge for repairs, in the event of the instrument being mistreated or damaged (excluding normal wear and tear) Repairs or adjustments shall only be carried out by Pencerdd Ltd or appointed agent.
14. If the customer defaults on any payments or fails to comply with these terms and conditions, Pencerdd Ltd may terminate this agreement by giving written notice to the customer. In that event the instrument must be returned or purchased immediately.
15. You can purchase or upgrade the instrument at any time, with 50% of completed rental payments from month 4 onwards deducted from the purchase price. Upgrades must be of the same type of instrument.
